

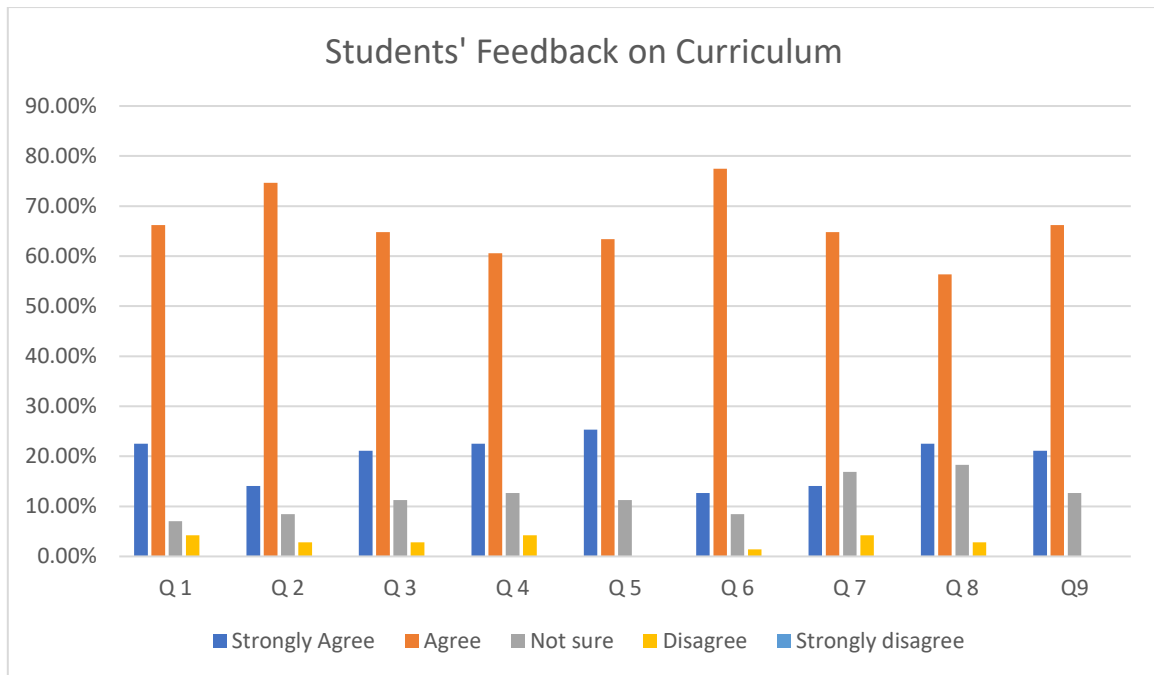

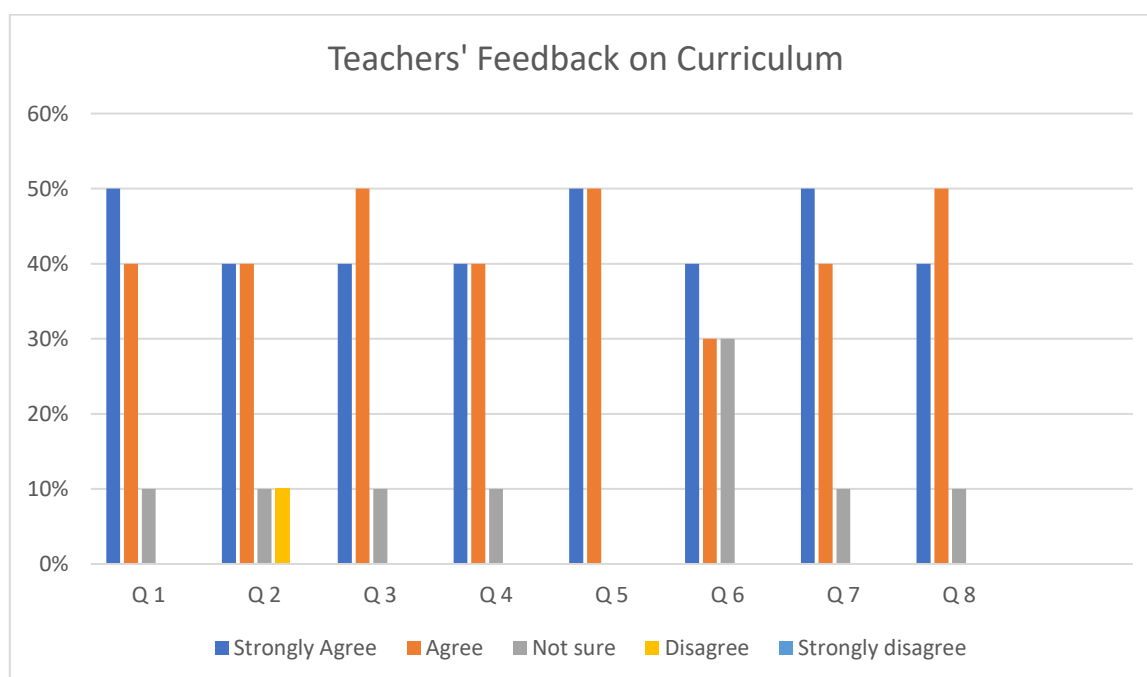


### Suggestions made:

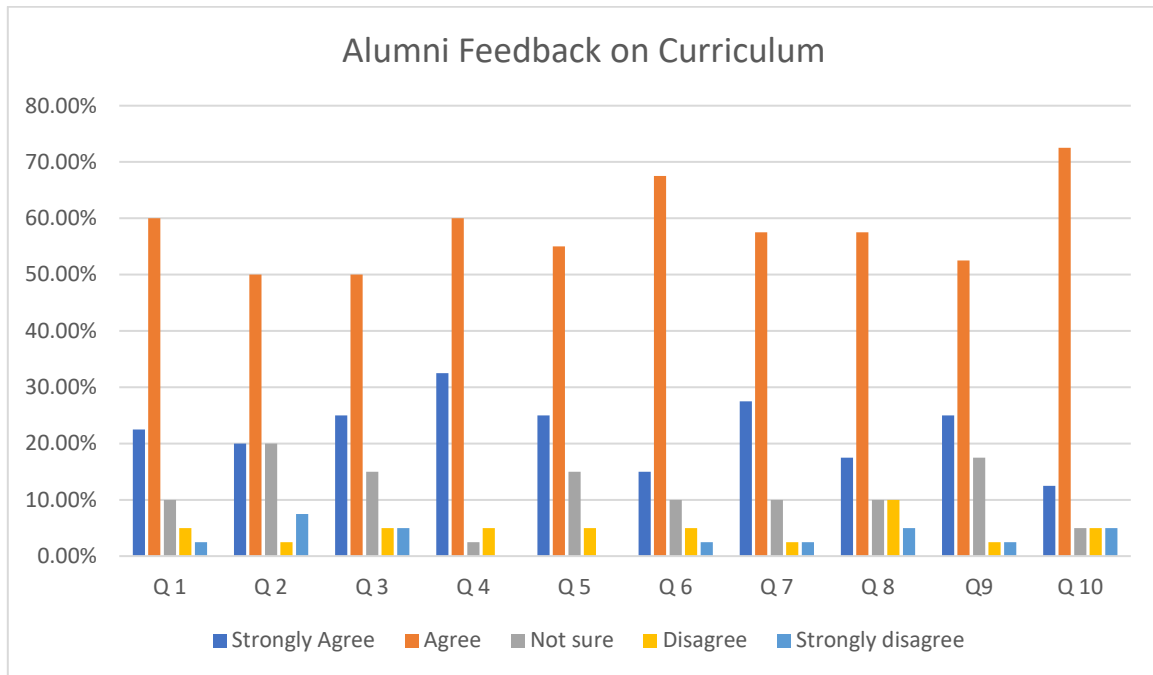


**Suggestions made:**
